Today, this project is known as a huge company that produces computers, phones, laptops, office equipment, televisions and related supplies under the logo of HP, or Hewlett-Packard.

Article 3 of the start-up law defines the word "Start up" as "a temporary structure" designed to look for and implement an extensible business model that has innovative components and requires high risk – based, specific investments".

In addition, Article 3 of the "Startup Act" comments on the concepts of "startup-ecosystem", "startup accelerator", "utility program".
